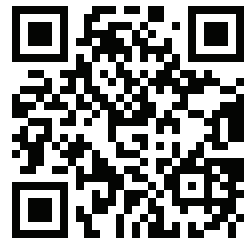


FURLANTHROPY CROWDFUNDING IS A REVOLUTIONARY RESOURCE!

HOW IT WORKS...

- Pet-Parent or Veterinarian team member visits furlanthropy.org
- Create a live Furlanthropy campaign in 3 minutes:
 - upload a photo or video of the pet
 - set financial goal and duration of campaign
 - give a description of need for funding
 - provide contact information of location of expense, ie: veterinarian office, vet clinic, etc.
- Campaign is shared by Furlanthropy, by the pet-parents, and by the veterinarians.
- As the funds are raised, they are sent directly to the veterinarian billing department.
- Prepaid expenses will be reimbursed
